Proceedings for selection of Agency for Baseline survey in Special program on Agriculture Production Cluster, APC under DMF- Keonjhar, on dt. 20th December 2022.

On 20th December 2022, under the chairmanship of the Additional Chief Executive Officer (Admn), Zilla Parishad, Keonjhar, and in the presence of the District Level Selection Committee (DLSC) members, the shortlisting of the agency for conducting baseline survey in Special program on promotion of Agriculture production cluster under DMF Keonjhar has been conducted in the conference hall of DDH, Keonjhar. The EoI for “ENGAGEMENT AS FACILITATING AGENCY FOR CARRY OUT BASELINE SURVEY IN EXTENDED 8 NOS. OF BLOCK OF KEONJHAR DISTRICT, ODISHA IN THE SPECIAL PROGRAMME ON AGRICULTURE PRODUCTION CLUSTERS UNDER DMF, KEONJHAR” from reputed Agencies/ Farms/Institutions/ Organizations of State and National had been invited by Deputy Director of Horticulture. The EoI document was hoisted over websites – www.keonjhar.nic.in / www.apcodisha.net / www.odishagov.in / www.odihort.nic.in) and advertising in two widely circulated daily Odia newspapers i.e Prameya / Pragatibadi and one daily English newspaper i.e The New Indian Express on dated 26.11.2022 for wide circulation. Further details of the EoI with application format were available over the website from 28.11.2022 to 15.12.2022 to be downloaded by interested agencies. The last date of receiving with filled in EoI form with documents was up to 5:30PM of 15.12.2022. The submission of EoI was through Speed Post / Registered post mode only.

At the outset Additional Executive Officer, Zilla Parishad, Keonjhar welcomed all the participating agencies and given the opportunity to introduce themselves. Deputy Director of Horticulture, Keonjhar briefed about the APC project and the selection process. Total 11 numbers of EoI applications received within the dateline was considered for the selection process and 2 numbers EoI application form received after the dateline which was been rejected by the committee. Nine number of agencies were present before the committee out of above 11 considered agencies.

The Eoi was opened in front of the member of the district-level selection committee and the participating agencies. Total of nine nos. of Eoi was opened for only those agencies whose representatives were present in the hall. Rest two nos. of agencies i.e (Nigama Institute for Governing Activities of Mass - NIGAM & Odisha Voluntary Health Association Lok Swasthya Bhawan) were not opened due to absence of their representative. The financial quotation of all the agencies was kept aside.

The selection process continued with the document verification of Nine agencies with respect to the application of the Eoi which they had submitted followed by presentation for all the Nine agencies in front of the selection committee.

As per the criteria mentioned in the Eoi, the grading for technical scores was done for all the agencies out of which only Four agencies named as Gres - India, Geen India, Bharat Gyana Vigyan Samiti and Lead Tech Management Consulting Pvt. Ltd. have qualified for the financial round. Thereafter the above four agencies were invited to present the financial quote before the committee

Final Score assessment:

QCBS pattern of 75:25, Technical Bid - 75% weightage (TW), Financial Bid - 25% weightage (FW). Proposals will finally be ranked according to their combined technical (ST) and financial (SF) scores as follows: $CS = ST \times TW + SF \times FW$

Where CS- Combined Score

ST- Technical Score

TW- Technical Bid Weightage

SF- Financial Score

FW- Financial Bid Weightage

TW & FW shall be 0.75 and 0.25 respectively.

GRES - INDIA scored highest in all aspects, So the committee unanimously selected the agency "GRES -INDIA" to conduct the baseline survey for all eight extended blocks of Keonjhar District. He has also expressed his willingness to conduct and complete the baseline survey within the timeline i.e 120 days.
